## NOTICE OF ATTORNEY OR NON-ATTORNEY ADVOCATE REPRESENTATION FOR UNIVERSITY STUDENTS

In accordance with North Carolina General Statutes section 116-40.11, section 700.4.1.1[R] of The UNC Policy Manual, and University policies and procedures, any student who submits a report of a violation under either the University's *Policy on Prohibited Discrimination, Harassment and Related Misconduct Including Sexual and Gender-Based Harassment, Sexual Violence, Interpersonal Violence and Stalking* (PDHRM Policy) or the University's *Policy on Prohibited Sexual Harassment Under Title IX* (Title IX Policy), or who is the subject of such a report, may be represented at their own expense by an attorney or non-attorney advocate of their choosing. This form must be submitted to the Equal Opportunity and Compliance Office (EOC Office) at least five (5) business days prior to the investigative, administrative, or adjudicative meeting or proceeding that the attorney or non-attorney advocate will attend. A record of this form will be maintained at the EOC Office.

Additionally, University students must complete and sign a release of information form providing consent for the disclosure of information and University records maintained by the EOC Office to their attorney or non-attorney advocate under applicable law. The release of information form also must be submitted at least five (5) business days prior to the investigative, administrative, or adjudicative meeting or proceeding that the attorney or non-attorney advocate will attend.
